SSURF-sponsored Teleconference With User Representatives

July 14, 2017

Records indicate that 29 people attended this teleconference; apologies for the missing names.

- Paul Runci provided an introduction to SSURF, its history and mission, and planned upcoming activities, including a user science exposition on Capitol Hill, SSURF-sponsored Congressional staff visits to facilities, and a pilot program for training reciprocity across facilities. He asked UEC chairs to encourage their facilities to join SSURF, if they have not already done so. No user meeting this year.
 SSURE should create a table of current organizational members and Fermilab is already a member.
- SSURF should create a table of current organizational members and website for easy reference.
- What are some effective ways the UEC chairs can mobilize the commusers quickly for outreach to Congress, when necessary? Some participants thought that a SSURF listserv could be a valuable platform for this purpose. It would also be helpful to have a common text/script available to help UEC members and users with outreach to elected officials. SSURF can provide the platform for UEC chair coordination and could help with development of scripts of this nature, provided they stop short of lobbying (i.e., making specific funding or policy requests).

Why SSURF?

- Education and outreach on behalf of the community as a whole.
- Third-party validation of user science.
- Coordination among facilities for benchmarking, best practices, and operational improvement.
- Coordination with/among academic and industrial users.

Mission

"Purpose. (...) advancing the science performed at user research facilities by (1) supporting their professional communities and research networks through the sharing of best practices and facilitation of professional development, and (2) promoting public awareness about the benefits and significance of the facilities and their research."

- SSRL has just gone through the process of contacting all of its users, which was a tedious process. The existence of standing SSSURF listservs would be a tremendous time saver.
 NUFO maintained listervs of this nature and they still exist, but need to be updated. The challenge is maintaining the listservs to keep them current. Could UECs work with SSURF to keep the listservs up to date?
- Other proposed roles that SSURF might play to assist the UECs and user communities:
 - Work with DOE on rewriting of Order on Foreign Visits; advise Sec. Perry on immigration;
 - Coordinate activities of other scientific societies (ACS, APS, MRS, etc.) as they relate to user science interests;
 - Post common calendar of events that facilities might refer to in scheduling meetings, allowing them to avoid scheduling conflicts; list workshops, UEC annual meetings, annual meetings, scientific society meetings, conferences, etc.
- How can UECs better coordinate to enable themselves to operate more effectively?
- Participants proposed a dedicated UEC Chair session at the SSURF annual meeting.

- Future SSURF-UEC teleconferences should be scheduled quarterly or no more than bimonthly; create schedule to synchronize with key federal budget dates (e.g., passback, release of President's Request, Congressional appropriations cycle) to allow UECs to engage effectively. (Paul R. will send chart illustrating 2-yr federal budget process).
- Subgroup teleconferences for NSF UEC Chairs would be valuable and would allow these individuals to coordinate meetings with NSF program managers, etc.
- Blaine Mooers briefed the group on the transition of SSRL to "warm standby" status in early 2018, as proposed in the President's FY18 Budget Request. SSRL's UEC mobilized users to contact their members of Congress.
- Someone suggested that the NSLS UEC could share its experience in facilitating the transition of users to other facilities in the event of the shutdown of a facility. They went through this experience with the transition from NSLSI to NSLSII.
- How well-coordinated are UECs with the government affairs activities of their facilities and national laboratories? There may be a need to coordinate/share information and messaging.
- SSURF could play a role in information coordination by linking UECs, labs, and universities, for example via coordination with university groups like Association of American Universities (AAU) and Association of Public Land Grant Universities (APLU).
- Since SSURF has applied for 501(c)(3) non-profit status, it cannot engage in lobbying activities.
- One participant raised the issue of the importance of data centralization to make it more publicly available to the scientific community. This topic might be a good candidate for a session at the FY18 SSURF annual meeting.
- It might be useful to dedicate an upcoming UEC Chair call to the question of listservs.
 There may be some hurdles to overcome to enable SSURF to create listservs, since it
 may be necessary to avoid use of .gov, and some .edu email addresses. What
 mechanisms do people currently use to manage listservs.
