





New feedback since 1. October 2019

- The coin dispenser machine in the laundry room in the village is not working for a while (checked for last three weeks). It requires repair/maintenance.
 - 10/4/2019
- One or more of the 3 Microwave Owens in the Wilson Hall atrium south-west corner that we use for warming the food at lunch time is/are not working for a while. It needs to be repaired or replaced.
 - 10/4/2019
- Housing agreement for village cannot be used to apply for driver license / bank account.
 - o If a user signs on a housing agreement for living in village the housing office provides an address proof letter supposed to be used for applying to a driving license/opening a bank account /buying car etc but the local DMV/banks are not accepting that address proofs stating the housing agreement does not include the word `lease contract` or something like that. Just want to bring this to your attention so we can have a discussion on how to address this and have a possible solution.
- Parking around high rise (x2)
 - Can anything be done about the reduced parking around the high rise? It is only getting worse for those of us who work here and the long walks in the winter will only make this more unpleasant.
 - Now-a-days there is not enough space for parking at Wilson hall parking lot and we are forced to park where there is not a parking place and we are receiving a fermilab parking ticket. Hoping to see more parking places alternatively."
