PPE Requirement and Other Protections

- ESH 5518: COVID-19 ES&H Information and Requirements
- Face covering is required all the time in MINOS
 - Face mask available from lab entry gate
 - We also ordered masks -- should be delivered to MSB
- At underground, wear hard hat
 - Nitrile gloves AND safety glasses or goggle (available check delivery)
 - Or nitrile gloves AND face shield (available check delivery)
- Wash your hands, clean shared tools frequently
 - Hand sanitizer station in MINOS
 - Alcohol spray bottles for disinfection of shared tools
- MINOS shaft elevator single person ride policy
 - First/last person enter/leave wait for 2nd person on the elevator
- Call MCR (x3721) first before getting keys
 - Can we get OPS group keys?
