Response to FSO Dose to Public Concern

Increase Area Monitoring

A number of locations throughout the Lab already have passive area monitors in place to monitor dose on a quarterly basis. These areas include some amount of space accessible to the public (i.e., Linac Pre-Acc tour location), users (i.e., FTBF) and other areas throughout the Lab. After looking at the current locations, and before performing the beam-on surveys, additional locations were identified to include in this area monitoring, to ensure that areas accessible to the public (i.e., not within locked buildings or fences) were appropriately monitored. Area monitors will be added to some "Additional Locations" during CY20Q4 with available area monitoring dosimeters.

All locations will be monitored and fully integrated into the RPO Routine Monitoring Program beginning CY21Q1, according to the following:

- All area monitors will use the Luxel style dosimeters
- The reports will be read down to the 1 mrem level
- There will be no background subtraction reports will show the raw dose evaluation
- There will be a new account created with Landauer to ensure clear separation of area monitoring and personnel/occupational dose monitoring.

Further locations may be identified and monitored following the beam-on surveys, and will be incorporated into the area monitoring program.
