#### Timeline

  - Continue working group conversations
  - Construct very detailed outlines
  - Get folks started on individual research assignments
- Jan-Mar:
  - Delegate writing of white paper (based on very detailed outline) to volunteers, subject matter experts

## White Paper 1 Progress (in good shape)

- Working Group/White Paper 1: Congressional Advocacy for HEP funding
  - This essentially maps onto the current/future scope of the annual "DC Trip"
  - Document will double as Snowmass white paper and also as thorough documentation of annual advocacy for use as part of that effort

#### Outline:

- Summary of how the DC Trip works (current state Congressional advocacy for HEP funding)
  - Who organizes/funds/attends the annual DC trip?
  - Summary of trip metrics (attendee demographics, number of meetings vs time, etc.)
- Summary of past funding as it relates to the advocacy effort
  - Detailed breakdown of requested, enacted funding levels vs time
- Moving beyond current infrastructure
  - Expansion of one-visit-per-year model?
  - Role of WHIPS moving forward?
  - Discussion of transformative change in our advocacy model

## White Paper 3 Progress (in okay shape)

- Working Group/White Paper 3: Non-congressional Government Advocacy
  - Existing and future engagement of executive branch agencies (OMB, OSTP, DOE, NSF)
  - What other governmental entities should we be engaging with?
  - (This is not currently as fleshed out as the white paper 1 outline)

#### Outline:

- Engagement with funding agencies
  - Not fleshed out
- Discussion of how we unify the community voice
  - Lots of discussion
  - Does this belong buried in white paper 3?
- o Discussion of potential local (e.g. state) and international engagement

## Specific tasks for getting plugged in

#### 1. Analysis of DOE and NSF HEP budget breakdowns since last P5

- a) Good to-do for an early career person thinking about a future in policy?
- b) Work with DOE and NSF to get numbers
- c) Compare appropriated budget to budget scenarios laid out in P5
- d) Analysis contribution to budget from items not initially in P5, i.e QIS

#### 2. Research on past PP&GE training and inreach

- a) What is provided by universities or labs?
- b) What is provided by HEP community, i.e at DPF meeting?
- c) Solicit input on what works well and what is lacking

#### 3. Research on the needs for future PP&GE training and inreach (post 2023 P5).

- a) How to disseminate the message effectively to the whole community?
- b) How to discuss how the plan has changed since 2014?
- c) What additional PP&GE outreach is needed?
- d) How to maintain PP&GE going forward?

# 4. Develop a mechanism to solicit PIs for recommendations on community communication with funding agencies

- a) Do Pls feel there are adequate mechanisms to speak to their Program managers?
- b) Do PIs have adequate input into the grant and review processes and is that input incorporated?
- c) Is there enough transparency and support with the grant and review processes?

# 5. Organize discussions with HEP leaders focused on maximising community commitment to unified P5 messaging

- a) Good to-do for later career person
- b) How to maintain commitment within the changing landscape between now and next P5?

#### 6. Summarize international involvement in US projects between Tevatron era and DUNE era.

- a) What fraction of collaborators on US projects have been from non-US institutions?
- b) Study policies impacting participation in US projects, and US participation in non-US projects
