

New feedback -- WH building air filtering status

Questions to ask WH building managers:

- What is the MERV rating on the filters in the WH HVAC system?
- Does WH use demand-controlled ventilation (I.e. the rate of ventilation slows as fewer people are in the building)?
- What is the air change rate for WH?
- Is the lab considering getting some portable air filters to help ventilate high occupancy spaces like conference rooms?

Lack of gender inclusivity in on-boarding in FermiWorks

I happen to be **renewing my FNAL computing** at the moment. In the **on-boarding in FermiWorks**, I was looking at the drop-down options for the Gender question and I was **pretty disappointed in the lack of inclusivity** for people who exist outside of the gender binary of the "Male" and "Female" options. **The only other option appears to be "Unknown"**. Whilst this is better than having only the binary gender options, using language such as "Unknown", "Prefer not to say" or "Other" further marginalizes nonbinary people and people whose gender identity is something other than these options, who in most cases clearly know and are proud of their gender identity.

While this does not affect me directly, I know of friends and colleagues within the Fermilab community who would be affected by the lack of inclusive options in the question.

Open feedback items -- Rent increase in the village

- I am very surprised to see that recently the housing rent got hiked by 17%. As a student, I can only afford the dorm room here. I am living at the dorm room currently. It is very hard for us to rent a outside apartment. As a federal lab, it is very unfortunate and unfair to set the room rent as compared to market value. We are staying at the Fermilab housing because it is cheaper than the market and we as a student can afford it. Taking as a fact that market value raising, housing can increase their rent step-by-step with little amounts instead of whole lots of 17%.
- Hello I am writing to seek your involvement in hiking the housing rent matters. Since, most of the residents in village are phd or summer students so it would be really too much if the rent increases by 17%. We don't have many facilities inside the village-like there is no laundry in most of the dorms, there is no water machine, rooms need paint and renovation, no one cleans the carpet fully, and on top of that they are increasing rents. It's a government property and its not understandable why housing people involve private company to get the rate estimate. All the furniture in all dorms and houses are old, nothing new has happened so why there is an increase in rent? Please step into this matter and help us.
- Feedback: The FNAL housing office has increased the rent by 17% at once. This is not acceptable as they are not adding any extra facilities. 5% increase is understandable but 17% is too much. It would be great if UEC considers talking to the housing office and come up with a more reasonable rate.
- Hey, I am *********, I am living at the Dorm *. I am very concern to know from housing office that my rent at dorm room will increase 30%. I am not getting any reasons or justifications for this announcement at this challenging time. Since housing are not implementing any new amenities (free washing/drying etc) for the dorm room, that's why it is very unfair to hike the rent a lot like 30%. Any small increments between 5-10% is manageable. The reason of market value agreement is very unfortunate, because federal lab don't want to make any profit from us. Please let us know your concern about this matter and how we proceed if we want to make any disagreement petition.
- Hello,I am very concern to know from housing office that my rent at dorm room (sharing kitchen and washroom) will increase ~32% from August however in the mail it was written 17%. I am not getting any reasons or justifications for this announcement at this challenging time. Since housing are not implementing the new amenities (free washing/drying etc) for the dorm room, that's why it is very unfair to hike the rent a lot like 32%. In 2019 it has increased 5% and again 32%. We understand the covid situation and any small increments between 5-10% is manageable. The reason of market value agreement is very unfortunate, because federal lab don't want to make any profit from us. Please let us know about your concern about this matter and how we proceed if we want to make any disagreement petition.

 - "Please identify if you were born in, are currently a citizen of, or are otherwise affiliated with a State Sponsor of Terrorism as identified by the U.S. Department of State (see https://www.state.gov/state-sponsors-of-terrorism/)."
 - The new wording is now implemented
 - Resolution:

Fermilab has reworded questions which now only asks people to identify if they were born in, are currently a citizen of, or are otherwise affiliated with a State Sponsor of Terrorism as identified by the U.S. Department of State (see https://www.state.gov/state-sponsors-of-terrorism/) as required.





Meeting Minutes

- The UEC quality of life received two new feedbacks during the last month, resolved one feedback and are working on eight feedback items in total.
- The new feedback is related to the absence of the VPN requirement specification in the password reset email. We have submitted a ticket to service desk on this topic.
- The other new feedback are the questions regarding the WH building air filtering status. We plan to reach out to FESS office.
- Another open feedback is the lack of gender options for the on-boarding form in FermiWorks. We now know that this is coming from the DOE database that is from 70s. We plan to submit this item to employee concerns and we also plan to contact Melissa Ormond and ask to reach out to DOE regarding this.
- The five feedbacks regarding the concerns related to the recent village housing rent increase are still open. UEC is still exploring ways to improve the situation in the future. We will hear an update on this soon.
- The resolved feedback is regarding the country of birth question. QoL confirms that the new wording of the question is now implemented in the Fermilab meeting registration pages.
