



# Oct 2024 NSG Report circualted

- "Summaries of the progress with FDs, ND and Software and Computing indicated strong progress in all areas."
- "Tracking DUNE progress is still challenging, partly due to the lack of tools to present well defined, reasonably spaced milestones and other metrics in a consistent way. A substantial number of past NSG recommendations are still not fully addressed."
- Recommendation: "Quantitative measures to track progress on the other aspects of the DUNE experiment (ND, Computing and Software) should also be shown at the spring NSG meeting."
- Recommendation: "The present risk register needs to evolve including a broader scope and risk mitigation plan."

#### **Executive Summary**

The NSG Committee had its third and final meeting of 2024 at Fermilab on October 23-25. The charge and the agenda of the meeting are attached at the end of this report. The committee concentrated on evaluating the process of coordination between international partners, assessing progress with previous NSG meetings recommendations, reviewing progress with Far Detectors (FDs) construction, Near Detector (ND), Software and Computing, and reviewing, for the first time, DUNE Common Fund.

We commend DUNE for strong progress in all areas since the June 2024 NSG meeting and for the informative presentations at the meeting and feedback on multiple committee questions and requests for additional information.



### **CRAB Discussion**

- Physics Coordinators are receptive to presentation by Mat about Software Coordination
  - They are still working on coming up with a plan from their side

## **DUNE Resource Review Board**

- "The DUNE Resources Review Board (RRB) is part of the international project governance structure for the Deep Underground Neutrino Experiment (DUNE). It was established to provide coordination among funding partners and oversight of DUNE. It is comprised of representatives of all funding agencies that sponsor the Projects, and of Fermilab management."
- Presentation last Friday regarding computing resources (hardware and effort) was made
- Question came about maturity of software (algorithms, framework, and infrastructure)
- Question came about fraction of university vs national lab effort on algorithmic development
- overall, good response and positive feedback from the spokepeople on the reception of the presentation



# **CCB** Preparation

- December meeting was planned to be the preliminary presentation of the model
  - date is not yet finalized, but a newdle poll was circulated in Sep
