

Ron Ray Stefano Miscetti	In Progress	We are in frequent contact with INFN about this issue. They received the approval of CSN1 in the spring of 2014. The final decision regarding their financial contribution will take place at a meeting in Fall 2014. There are entries in the Risk Register that address a potential short-fall or surplus relative to what we've assumed in developing the baseline cost/schedule.
