Brief Update on the LBNO/LBNE engineering work – 10 mins --- J. Strait

- Three main areas of work: Risk Analysis, costs comparison, Rock Mechanics
- Face-to-Face meetings planned for week of January 12

LOI writing team update - 10 minutes ---- R. Roser, K. Long

- Need strong physics case for 10 kt; better governance statement; more fleshed out on non-oscillation physics nucleon decay and Supernova neutrinos; need more about near detector and clarity on a number of issues.

Brief status of International Governance Working Group – 5 mins --- J. Lykken

- Three meetings, focusing on LHC model, now pretty comfortable
- Joe Lykken asked for a draft which Jim Strait produced; next to discuss with DOE, then to rest of working group and send to iIEB.
- Plan is to distribute at December 5, 12 open meetings.

Discussion of the Submitted proposals - N. Lockyer

- Discussion by Nigel, Joe and Rob, distributed this morning
- Group (Antonio, Chang Kee, Ed Blucher, Andre, Bonnie, Carlos, Mark, Brajesh) agrees that interim IB chair should be drawn from iIEB. Joe Lykken addressed concerns it could be drawn from a broader list....keep it simple for now.
- several members suggest the collaboration has ownership of everything in the end

- Brajesh wants to make sure that international partners are adequately included and their interests are considered
- Regarding subcommittee to produce Memorandum of Collaboration
- See comments by Mark Thomson just circulated to the group during the meeting.
- MoC should present options, even if the committee says which one it prefers but new collaboration should have final word (Blucher)
- interim IB chair would be involved in drafting (Chang Kee)
- need to discuss role of collaboration leadership in the international governance plan: Milind
- Jim Strait: this is intersection of iIEB and Joe Lykken's working group
- Chang Kee: Early job of collaboration is to establish a constitution writing committee. MoC would concentrate on setting up structure necessary to get there, concentrating on selecting leadership but not too much beyond.
